

RATE SCHEDULE

IRRIGATION – RATE 20

Availability

Irrigation service is available to all members in accordance with the Cooperative's Service Rules and Regulations for the following purposes:

- (1) for irrigation wells, irrigation machines, lake pumps, tail water pumps, irrigation booster pumps, and
- (2) grain dryers served from the same service as an irrigation well.

Character of Service

Single or three phase service at the Cooperative's standard voltages where available.

Monthly Rate

Each billing period the member shall be obligated to pay the following charges:

- (1) Service Availability Charges \$4.1667 per horsepower per month for the months of February through July inclusive.

This Service Availability Charge is non-refundable and does not include any KWH's of energy; and

- (2) Energy Charge

(a) April through September billing periods \$0.07115 per KWH

(b) October through March billing periods \$0.06115 per KWH

This charge for the delivery of energy shall be applied to all KWH usage during each billing period.

Reconnected Services

If service provided under this rate is requested to be reconnected any time during the current calendar year an amount equal to the service availability charges that would have otherwise been billed had the service been connected during the entire current calendar year will be required to be paid prior to re-connection of service.

Determination of Horsepower

The horsepower for billing purposes shall be the maximum connected horsepower. The connected horsepower for each motor shall be the motor manufacturer's name plate rating of horsepower output, except that, if the Cooperative so elects, it shall be determined by actual measurement of power input during a period of maximum use.

Horsepower Adjustment for Power Factor

The member agrees to maintain unity power factor as nearly as practicable. The horsepower for billing purposes shall be adjusted for members with 65 horsepower or more to correct for average power factors lower than 85 percent, and may be also adjusted for other members if and when the Cooperative deems necessary. Such adjustments will be made by increasing the measured horsepower one percent for each one percent by which the average power factor is less than 85 percent lagging.

Minimum Charge

Each calendar year the member shall be obligated to pay the greater of the following charges in addition to any energy or billing adjustment charges whether or not any energy is actually used :

- (1) The amount stated if any agreement with the member; or
- (2) \$25.00 per year per horsepower in Service Availability Charges.

Delivery Point

Unless otherwise specified in the service contract, the delivery point shall be the metering point when service is furnished at secondary voltage, or the point of attachment of the Cooperative's primary line to the member's facilities if service is furnished at primary line voltage. All wiring, pole lines, and other equipment (except metering equipment) on the load side of the delivery point shall be owned and maintained by the member.

Billing Adjustments

This rate is subject to all applicable billing adjustments.

Primary Service

If service is furnished at the Cooperative's primary distribution voltage, a discount shall apply to the charges specified in the applicable rate schedule. The cooperative may meter at secondary voltage and adjust to primary metering by adding the estimated transformer losses to the metered kilowatt hours and kilowatts. The discount for primary service shall be three percent (3%). The discount will not be applied to any Billing Adjustments.

Horsepower and Power Factor Metering

The Cooperative shall have the right to make power factor and/or horsepower measurements by test at any time, or install meters permanently, or agree with the member on estimated horsepower and/or power factor to be used for billing.

Terms of Payment

Each bill for utility service(s), regardless of the nature of the service(s), is due 16 days after issuance unless such day falls on a holiday or weekend, in which case payment is due on the next working day. **If full payment is not received in the office of the Cooperative on or before the date such bill is due, the entire Member's account will be considered delinquent and subject to disconnection.**

Line Extensions

The Cooperative will make line extensions in accordance with the applicable line extension policy.
